

PROFILE OF HOMELESSNESS IN METROPOLITAN DENVER, COLORADO 2004 Homeless Point-In-Time Study


Key Findings

- On January 19, 2004 the designated "point-in-time" the count of the homeless in • Metro Denver numbered 8,668 persons.
- Single persons not in families represent 39 percent of all homeless persons, while family • members represent 61 percent.




Infants, children and youth under 21 years old, represent 42 percent of the homeless • population sampled.




Homelessness and Age

• At the time of the January count, 19 percent of homeless persons had been homeless for less than 30 days and 17 percent had been homeless for more than two years.




• Of all the homeless persons, 34 percent were homeless for the first time. Of the single homeless, 30 percent were homeless for the first time and 42 percent of the homeless families were homeless for the first time.




Family Status and Prior Homeless Cycles - Respondents

• The estimated annual prevalence, based on the 2004 figures, is that 25,509 persons in Metro Denver will experience homelessness at some time during the year.

• The night before the completion of the homeless questionnaire, 2,442 persons were in transitional housing, which represents 28 percent of the total number for which data was available. The remaining 72 percent could be considered to be in need of these services, as they lacked permanent places to stay and were sleeping in emergency shelters, motels, doubled up with family or friends, had just left an institution, or were staying in a location not designed for human habitation, such as a car or under a bridge.



• The majority of the homeless persons are located in the suburban counties. Only 40 percent are located in Denver; 17 percent are in Adams County; 17 percent are in Jefferson County; 15 percent are in Boulder County; 8 percent are in Arapahoe County and less than 1 percent of the sample was located in Douglas and Broomfield Counties, respectively.



The People Behind the Numbers

These are not actual people, but these stories represent realities seen every day.

Marge and Bob

Marge and Bob, both in their thirties, have four children under five years of age. Bob recently became disabled and lost both his job and medical insurance. This family had a home of their own and a little savings, but they lost those assets paying for medical bills. They lived in a cousin's basement for a month, but that didn't work out and now they are in a shelter. Marge is looking for work. Bob looks after the children while she is out. They are not sure if they can find safe and affordable housing on Marge's earnings.

Loretta

Loretta, age 22, is a single mother with Jared, her four-year old son. She left Jared's father because he abused them. She feels that was a good decision, but now she is in a domestic violence shelter and doesn't know where she'll go when her time is up. Loretta never completed high school and has few work skills, but she wants to get training so that she can be independent.

Umberto

Umberto, age 45, is a single dad with a teenage son who has serious medical problems. His wife left them a long time ago. He works but often has to leave work to care for his son. As a result he can't earn enough to keep them housed. Because they are not citizens, they are not eligible for some public programs that might help with housing.

Henry

Henry, age 67, was recently released from jail with just pocket change. He has a history of alcoholism and substance abuse. Henry has lived in Denver all his life but has no connections with family or friends. Often he sleeps in an alley or under a bridge.

Coretta

Coretta, age 13, is alone. She ran away from her home in Iowa because her stepfather was sexually abusing her. She came to Denver because she thought her aunt lived here but she has never found her. Coretta hangs out with other kids on the mall and sleeps where they do. Sometimes she resorts to prostitution to get money for food and cigarettes.

PROFILE OF HOMELESSNESS IN METROPOLITAN DENVER, COLORADO 2004 Homeless Point-In-Time Study

Introduction

The Metropolitan Denver Homeless Initiative (MDHI) annually conducts a "count" of the homeless population in the Metro Denver area as of a specific point in time. For 2004, the point-in-time was January 19th. One hundred and twenty separate programs that serve the homeless (some agencies had as many as seven programs) participated in the 2004 collection of information.

An accurate profile of the homeless population facilitates service provider planning to address unmet needs, and it provides the data necessary to enable Metro Denver to secure federal funding for the homeless. A further purpose of the data collection is to learn about the causes of, and contributors to, homelessness and to document the services utilized by this population.

Count of Homeless Persons on Point-in-Time Date

On January 19, 2004 – the designated "point-in-time" – the count of the homeless in Metro Denver numbered 8,668 persons. There were 4,127 respondents to the homeless questionnaire. (See Appendix 1.) Single persons represent 63 percent of all questionnaire respondents, but family members represent almost 61 percent of all homeless persons counted. (See Table 1 and Figure 1.)



Age and Living Situation Homeless Persons

Age and living situation are available for 8,312 of the persons counted. The 3,484 children and youth, aged birth through 20, represent (42%) of all homeless persons. This group includes youth on their own, youth with friends, youth heads of families, and children and youth with their parents in families. There were 260 homeless youth on their own and 209 youth who were heads of families or part of a couple.

"Single persons, not in families" (3,242) represent 39 percent of all homeless persons, while family members represent 61 percent. "Single Persons" includes those who stated that they were "single, living alone," as well as, "single, living with friends." Also included is the number of friends who were living with the homeless single person. This group combines adults and youth under 21 years of age.

The "Family Member" category includes all head of household respondents, whether in couples or one- and two-parent families. Also included are the spouses and children who these respondents stated were living with them. This group combines adults and youth under 21 years of age. (See Table 2 and Figures 2 and 3.)



Homelessness and Families



Type Of Place Where Homeless Persons Spent Last Night

The night before the homeless questionnaire was completed, 2,442 persons were in transitional housing, which represents 28.5 percent of the total number for which data were available. The remaining 71.5 percent of the group could be considered to be in need of these services, as they lacked a permanent place to stay and were sleeping in emergency shelters, hotels/motels, doubled up with family or friends, coming out of an institution, or staying in a location not designed for human habitation, such as a car or under a bridge. (See Table 3 and Figure 4.)

Place Slept Night Before Survey



A greater percentage of those respondents in transitional housing have been homeless for 6 months to 5 years than is true for those respondents in other non-permanent housing situations. The reverse is true in the under six months and over five year categories. (See Table 5.)

Duration of Homelessness – Total Persons

At the time of the January point-in-time questionnaire, 646 respondents stated that they had been homeless for 30 days or less. Living with them at that time were 885 other persons (family members or friends) for a total of 1,531 (18.8%) *newly homeless persons* on January 19, 2004. (See Table 6 and Figure 5.)



Annual Prevalence Estimate

To estimate annual prevalence, one assumes that the number of *newly homeless persons* (*i.e.*, homeless for less than 30 days at the time of the point-in-time questionnaire) is consistent over the year, yielding 16,841 new homeless persons ($11 \times 1,531$) per year. When this figure is added to the point-in-time prevalence of 8,668, on January 19th, 2004, it yields an annual prevalence estimate of 25,509.

Cycles of Homelessness

One third of the respondents were homeless for the first time at the time of the questionnaire. A slightly higher percentage of heads of families were homeless for the first time than were single respondents. The majority of respondents have had more than one cycle of homelessness. A greater percentage of single respondents than heads of families reported being homeless for six or more cycles. (See Table 7 and Figure 6.)

Family Status and Prior Homeless Cycles - Respondents



Causes of Homelessness

Both single persons and head of household respondents identify the major causes of homeless as "they lost their job" or "they were unable to pay their rent or mortgage." A higher percentage of single persons than heads of household identified substance abuse and mental disabilities as causes of homelessness. A higher percentage of heads of household than single persons identified domestic violence and relationship problems as causes of homelessness. (See Table 8.)

Respondent Age Grouped: Most homeless respondents (85.4%) are between the ages of 21 and 60. Almost 1 in 10 respondents (9.5%) is younger than 21 years of age; only 2.5 percent of respondents are 61 years of age or older. (See Table 10 and Figure 7.)




Age Intervals of Respondents: Homeless respondents younger than 15 or older than 70 report being alone without families. Respondents, ages 21 to 40, are more likely to be in families than to be single. Respondents, ages 41 to 70, are more likely to be alone than with families. (See Table 11.)

Age Breakdown of Children Living with Respondents: Respondents report that 3,278 children were living with them the night before completing the homeless questionnaire. Of the 2,662 children for whom a specific age was reported, 1,201 (45%) are five years of age or younger while 1,461 (55%) are between six and 18 years of age. (See Figure 8)

Gender: Respondents were asked to identify their gender as male, female or transgender. Males and females are equally represented among the total group of respondents. The majority of single homeless respondents living alone are male, however. In contrast, the vast majority of single parent respondents with children are female. (See Table 12 and Figure 9.)

Homeless: Gender and Family Situation





Homeless Respondents: Annual Income




Last Permanent County Residence of Homeless Persons and Their County **Location Immediately Prior to Questionnaire**






County Last Permanent Housing/County Spent Prior

Homeless persons reported a last permanent residence in 41 Colorado counties outside of Metro Denver, 41 states outside of Colorado, and 10 countries outside of the United States. Complete tables about last permanent residence and location where homeless persons spent the prior night are in Appendix 2.

County Demographic Profiles of the Homeless and County Breakdown of Questionnaire Responses

Appendix 3 contains demographic profiles of the homeless respondents by metropolitan county. Included are breakdowns by age, gender, ethnicity, family status, and income. Appendix 4 includes cross tabulations of all questions by county where the respondent spent the prior night.

Service Utilization: Prior Treatment

Respondents were asked if they had ever received, or were currently receiving, treatment for serious medical conditions. Single persons were more likely to indicate treatment for mental illness and substance abuse than were heads of household. Heads of household were likelier to indicate treatment for domestic violence than were single persons. One third of single persons and almost half of heads of household had never received or were not now receiving treatment services. (See Table 16 and Figure 14.)

Percent of Homeless Receiving Prior Services by Family Status



Participation in Military or Foster Care

A greater percentage of single persons than heads of household had prior experience in the military or foster care. Overall, one in 8 homeless respondents had been involved in the military and the same ratio existed for those respondents who reported having been in foster care. (See table 17.)

Sources of Income

Homeless persons have various sources of income, including connection to the workforce or receipt of public benefits. Full or part time jobs or unemployment benefits provide earned income for 1,430 respondents to the survey, both single persons and heads of household. That number represents over one third (34.7%) of all homeless respondents. Almost one quarter of heads of household report receiving TANF and over one third receive food stamp benefits. (See Table 18.)

Conclusion

This report presents a profile of homeless people in Metro Denver as of January 19, 2004. It is surely an undercount and does not represent all of those who were homeless on that date. It does provide, however, a useful picture of a large number of Metro Denver citizens who are clearly in need of permanent housing and services.

The face of homelessness has changed from that of a decade ago. Homelessness is no longer just a problem of single men with substance abuse problems in urban centers. The majority of homeless persons today are family members, and two out of five are under 21 years of age. The majority of homeless persons are found in the suburbs, not the center city. While over more than one-third continue to work while homeless, a large percentage report that their homelessness was precipitate by a loss of a job.

Homeless is no longer only a chronic condition. One third of homeless persons, at any given time, have never been homeless before. Only one in six has been homeless for more than two years.

Among the homeless today are youth who have aged out of foster care, military veterans, victims of domestic violence, and persons with physical disabilities. While some homeless persons have problems with alcohol and substance abuse, more have severe mental illness. Homeless persons today come in all genders, ages, racial, and ethnic groups. While one in six homeless persons report no income at all, one in fifteen report income in excess of \$20,000 annually.

On any given night, approximately 8,000 persons are homeless in Metro Denver. Many of these persons are no different than Metro Denver residents with permanent housing, except that when faced with a financial crisis, they had neither the personal savings nor family support to enable them to maintain safe and adequate shelter.

As a personal problem, homelessness is dehumanizing for adults and terrifying for children. As a societal problem, homelessness merits public and private attention and resources, because it affects not only those who experience it, but also those who live in communities where homelessness is allowed to exist.

APPENDIX 5: Technical Report 2004 Profile of the Homeless in Metro Denver Technical Report

Purpose of the Research

The purpose of the current research is to determine an accurate count of the homeless population of Metro Denver as of a specific point in time in 2004. This count facilitates service provider planning to address unmet needs, and it provides the data necessary to enable Metro Denver to secure federal funding for the homeless.

A further purpose of the research is to learn about the causes of and contributors to homelessness. It is also possible through this research to document the services utilized by this population.

Limitations of the Research

A major limitation of the present research is inherent in all research into the problem of homelessness. The population is mobile. They are difficult to count because they utilize many different resources in a day; they may not be in any organized resource; or they may be on the street and unavailable. Additionally, homeless individuals can be disorganized or disoriented making it difficult to get accurate and consistent responses from them.

Adding to the difficulties with the population, the agencies that administered the research questionnaire are often understaffed and coping with inordinate demands. This contributes to incomplete data collection and inability to supervise respondents.

Given the limitations, however, the data collected is crucial to understanding and assisting this population. If there are inaccuracies in the count, they are likely a gross undercount due to an inability to locate and enlist all those who could have contributed information.

Sampling Approach

All agencies participating in the Metro Denver Homeless Initiative and others serving the homeless were asked to have their clients/participants complete a questionnaire about themselves. The point-in-time date was January 19, 2004. Questionnaires were completed during the period from January 20 to January 23, 2004.

All participating agencies were invited to a training session about the questionnaire. Agencies were asked to have staff persons assist their clients in completion of the questionnaires. In many instances, this was not possible and clients completed the questionnaire themselves.

Questionnaires were available in English and Spanish. Of the 214 questionnaires completed in Spanish, 16 were too incomplete to use, 35 were from respondents determined to be non-homeless, and 163 were included in the final homeless data base of 4,127 respondents.

Cleaning the Database

Several assumptions were applied to the process of cleaning the database so that it would more accurately determine the "point-in-time" count of the homeless. These are conservative changes that more accurately portray the data. These changes also make for consistency within the database.

- If "living situation" was missing, the researchers looked at the "number of persons" or "number of children" whom the respondent identified that s/he lived with currently, their gender and age, and then the researchers assigned a living situation. For example, a man, age 49, who had no living situation specified but put 0 for "persons living with." That record was classified as "living alone". Likewise, a woman, age 23, who had no living situation specified, was recounted as "single parent with children" because she said that she lived with two children.
- Another step was to make the number of persons "living with" match the living situation. For example, if a respondent checked "couple with no kids," the researchers corrected the numbers of those "living with" to read 0 in the "kids live with" column and 1 person in the "live with" column.
- For one parent and two parents, the researchers made the "live with" and "kids live with" match. For example, for two parents "live with" became one more than "number of kids live with." For single parents, if they checked 0 or left a blank space in the "live with" and "kids live with" categories, the researchers assumed that the respondent must have at least one child and put a 1 in those categories.

Questionnaire Design

The 2004 questionnaire was a refinement of the prior year's questionnaire instrument, adapted to reduce inconsistency and increase accuracy. The principle investigator and MDHI Data Collection Committee participated in these revisions. Several items in the 2004 questionnaire still caused respondent confusion and a further refinement is planned for next year.

Definitions of Homeless and Non-homeless

All respondents were asked if they considered themselves to be homeless. Because this question was answered inconsistently it was not the factor that determined if they were included in the homeless database. Some persons said they did not consider themselves to be homeless even though they spent the prior night on the street, or said they had been without a permanent residence for five years or more and had no income. Others said they did consider themselves to be homeless even though they said they spent the prior night in "an apartment or home that they rent or own" and reported more than \$50,000 in income. Eight out of ten (83.1%) of the respondents considered themselves to be homeless. (See Table 1.)

All the agencies soliciting respondents serve the homeless, but some services are offered to homeless and non-homeless alike, resulting in some persons who, while in great economic need, are not homeless. People were considered to be non-homeless, if:

a) they said they spent the prior night in permanent subsidized housing (for the formerly homeless or non-homeless); or

b) they said they were not homeless AND lived in an apartment or house they owner or rented, AND did not complete the questions about number of homeless episodes or length of homelessness.

Number of Questionnaires Completed in 2004

There were 5,032 questionnaires collected in 2004, but 63 were too incomplete to be entered in the database. Of the 4,969 questionnaires entered, 115 files were subsequently deleted (114 were duplicates, and one was a child respondent of nine who listed a residence in foster care). Of the 4,854 remaining questionnaires, 727 were determined to represent non-homeless persons who could not be included in a count of the homeless. The final database of homeless persons consisted of 4127 completed records.

Comparisons With Prior Year Data

In 2003, a total of 5,709 questionnaires were deemed usable, but the total number of questionnaires collected (including unusable and duplicate questionnaires) for 2003 is unknown. From the 2003 database, 510 questionnaires were determined to represent non-homeless persons and were removed, leaving a homeless database of 5,199 records used to determine the count for 2003. (See Table 2.)

Methods for Dealing with Differences between 2003 and 2004: The number of questionnaires collected for 2004 were less than those for 2003. This resulted in a lower point-in-time count of the homeless and a lower annual prevalence estimate. Reasons for the reduced numbers of questionnaires and methods to deal with this situation are suggested below.

• Potential reasons for difference in numbers of homeless questionnaires between 2003 and 2004

Fewer questionnaires were collected in 2003 than 2004 even though more agencies participated in 2004 than 2003. While this decrease might represent a reduction in the number of homeless persons in Metro Denver, it is equally likely that it reflects program cuts resulting in fewer staff available to be involved in outreach efforts and agency-based data collection.

In 2004, 120 separate programs (some agencies had as many as seven programs) solicited questionnaires. In the prior year, 2003, 106 programs recruited respondents. Twenty-seven programs from 2003 did not participate in the 2004 questionnaire, although a number of new programs were involved in 2004. Some programs that were involved in both years contributed far fewer questionnaires in 2004 than 2003. For example, one program collected questionnaires in both years but their 2003 number of 265 questionnaires was reduced to 106 in 2004; likewise, another program supplied 502 questionnaires in 2003, but only 303 in 2004.

It appears that in the 2003 and 2004 databases similar definitions were used for those individuals to be included in a count of the homeless. People in permanent subsidized housing for the homeless were excluded in both years.

Alternative Approach to Estimating Annual Prevalence

Prior approaches to estimate annual prevalence, assumed that the *newly homeless persons* were those who had been homeless for less than 30 days at the time of the point-in-time questionnaire. Further analysis of the 2004 data suggests a different approach. While there were 1,531 persons who indicated that they were homeless for less than 30 days, only 589 were also homeless for the first time. This is the group that might be considered truly <u>newly homeless for the 2004</u>. The 2004 question about the number of times a person had been homeless prior to the current episode did not specify whether the time period was within the past year or in prior years.

Using the 589 number of persons who were homeless for less than 30 days AND never before homeless, and multiplying that by 11 (to avoid double counting in the 12th month) yields 5,841. That amount added to the 2004 count of homeless persons (8,668) yields an annual prevalence estimate of 14,509 persons who will likely experience first time homelessness in Metro Denver during the year. This total is about half of the prior estimate and this approach provides an alternative, more conservative estimate.
